I fully understand and acknowledge that outdoor recreational activities have: (a) inherent risks, dangers and hazards and such exists in my use of Brenda Schultz Sports Camp LLC and Hollins University equipment and my participation in Brenda Schultz Sports Camp LLC and Hollins University activities; (b) my participation in such activities may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of Brenda Schultz Sports Camp LLC and Hollins University; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes. I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees or contractors of Brenda Schultz Sports Camp LLC, Hollins University, or by any other person.

I, on behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Brenda Schultz Sports Camp LLC, Hollins University, and its owners, agents, officers, employees or contractors from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of participation in activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers, employees or contractors of Brenda Schultz Sports Camp LLC and Hollins University.

The Venue of any dispute that may arise out of this agreement or otherwise between the parties to which the Brenda Schultz Sports Camp LLC and Hollins University or its agents is a party shall be in the County Courts in Roanoke County, Virginia.
